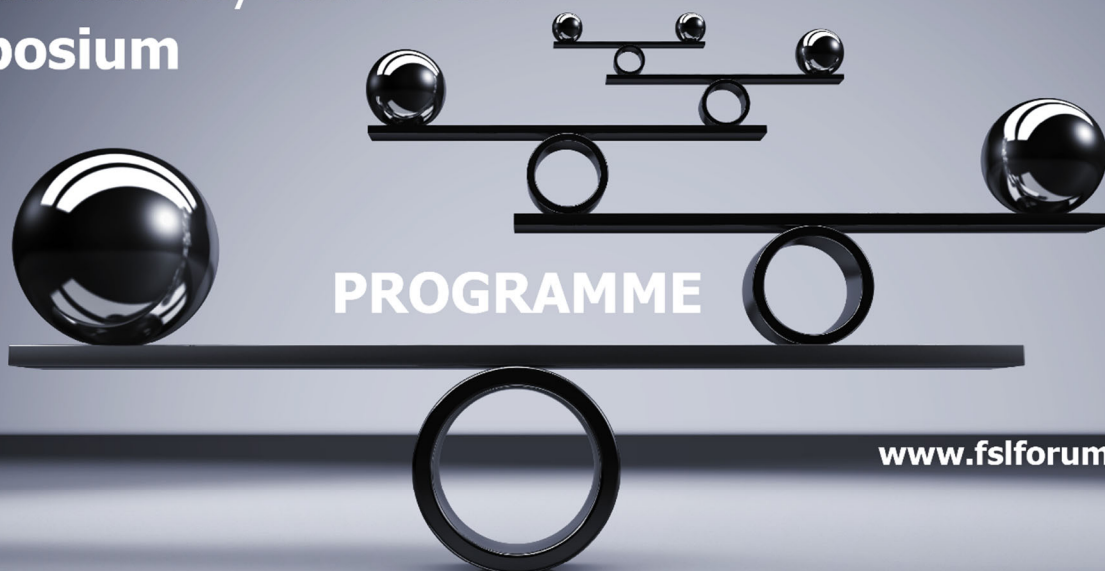

Symposium

The recent banking crises in the spring of 2023 have reinvigorated the debate on systemic risks in the financial sector and their supervision and containment through regulation.

The symposium offers an opportunity for in-depth discussion. The morning session focuses on 'Market Confidence and Crisis Prevention', while the afternoon is dedicated to 'Crisis Management and Resolution'. Each topic will be introduced by a keynote from the Deputy Governor of the Bank of England and the General Counsel and Director of the Legal Department of the International Monetary Fund, respectively. Experts and key figures from domestic and international authorities will then provide input presentations, which will be further explored in four panel discussions.

The event is aimed at those involved in the legislative and regulatory process in politics, administration, and industry associations, in-house counsels of banks, law firms with financial market expertise, and researchers. Other interested parties are welcome.

Financial Stability Law Forum

Seven law professors from six Swiss universities have joined forces in the Financial Stability Law Forum (FSL Forum) to discuss stability issues such as the Too Big To Fail problem in Switzerland from a legal perspective.
